3. Report and Consideration on a Resolution Regarding Housing Authority Insurance Coverage

Mr. Johnathan reported that this was brought to the Board last month and due to a typographical error, the wrong amount was awarded to American Family Insurance. The corrected amount for the contract is \$94,232.00.

In order to recoup some cost for re-doing the loan satisfaction paperwork, the homeowner will be charged if we need to provide an additional SAT after the initial SAT was already provided.
