## SURVEY QUESTIONAIRE

#### Dear Resident:

You have been randomly selected to participate in a survey to obtain your opinions concerning Half Moon Lake. For those of you not familiar with the lake, Half Moon Lake is a 132 acre oxbow lake of the Chippewa River that surrounds Carson Park on the City's lower west side. A map of the City showing the location of the lake can be found on the last page of the survey.

Approximately one year ago the Eau Claire City Council authorized to have two studies be completed concerning Half Moon Lake. One study which is currently being undertaken is a technical study of the water quality issues involving the lake. The study is being completed by the U.S. Army Corp of Engineers. The second study is a study of community use of the lake and is being completed by a citizen's task force that has been appointed by the City. This survey is one of the methods being used by the Task Force to obtain this community input.

The purpose of the survey is to help provide background information for the Eau Claire City Council concerning the community's perceptions and feelings about the current state of the lake. The City hopes to use information gained from the survey along with information gained from the technical study to help make decisions on issues concerning the lake, including: future uses allowed on the lake, desired water quality, maintenance standards desired by the community, improvements that should be considered, etc.


