5. Director's Update / Board Announcement & Directives

Mr. Johnathan reported that a CDBG Rehabilitation Loan Client passed away a couple of years ago and the family has been squatting on the property. The Housing Authority purchased the property through the Sheriff's sale for \$48,000 and possibly intends on rehabbing the unit for the Home Ownership program.

Mr. Johnathan reported that the Housing Authority has determined that the RAD (Rental Assistance Demonstration) program conversion for Public Housing has been halted and will no longer be pursued at this time. The conversion is designed to help troubled Housing Authorities and was more restrictive with the funds. As we are a high performing agency, the conversion and the rules were inappropriate for our needs.

Commissioner Kincaid announced that a task force for the Historic Randall Park Neighborhood was created and the report they submitted as part of the City's Comprehensive Plan suggested a Landlord Registration and that a non-profit be formed to buy, rehab/convert the rental units in this district, and sell them to lower income families. Commissioner Kincaid suggested the Housing Authority Board should review the report. Mr. Johnathan said he would get a copy of the report and have it in next month's Agenda.
