# You have received an ordinance citation for Excessive Intoxication in the City of Eau Claire:

If this is your first offense and:

 You are currently enrolled at the University of Wisconsin- Eau Claire, you will have the option of working with the Dean of Students Office to enroll in the "BASICS" educational program through UWEC. Cost for Program: \$200.00.

OR

You are not a student of UWEC, you will have the option of enrolling in the Eau Claire Stop Excessive Intoxication Program (EC-SIP) taught by staff from the Eau Claire Police Department and the Eau Claire City County Health Department. Cost for Program \$200.00.

Upon successful completion of either program, your citation will be dismissed.

If you choose not to enroll in either program or you do not qualify (2<sup>nd</sup> offense or more) your options follow the same protocol as any other ordinance citation in the City of Eau Claire.

### **ELIGIBILITY**

- This is your first citation for Public Excessive Intoxication.
- EC-SIP will be available to individuals of any age receiving a Public Excessive Intoxication Citation for the first time.
- BASICS will only be available to UWEC students who have received a Public Excessive Intoxication Citation for the first time.

### **ENROLLMENT**

- Prior to your court date, complete the Enrollment Information (on next column) requesting to participate or you can appear in court, on your assigned court date, and request to enroll in the program.
- The completed Enrollment Information form can either be mailed to the Clerk of Courts Office, or you can physically drop it off at the Clerk of Courts Office during business hours. (M-F, 8:00 a.m. - 4:30 p.m.)
- Clerk of Courts will verify if you are eligible for this program. Clerk of Courts will then notify the specific program, on or before your court date, of your eligibility status.
- 4. Once you have mailed or dropped off the Enrollment Information, it will be <u>YOUR</u> responsibility to register and make payment for the program. This can be done by the following:

- Upon completion of the program, the Program Administrator will provide the Clerk of Courts proof of completion and the Clerk of Courts will initiate dismissal of the citation.
