Further, if room tax income for 2010 exceeds projections, the City's portion of the additional income will be allocated to the Parks CIP.

Motion to increase funding for Community Beautification by \$500, increase funding for the Chippewa Valley Museum by \$5,000 and reduce funding to the Paul Bunyan Logging Camp by \$5,500.

Motion to transfer \$100,000 from the 2010 Forest Street parking lot shown in the Parking Utility Capital Improvement Plan to the General Fund seal coating program and to reschedule the Forest Street parking lot for 2011 in lieu of the 2011 parking ramp maintenance.

Motion to allocate \$100,000 from the anticipated proceeds of the sale of the former UW Health Building to the 2010 seal coating program.
