NARRATIVE:

At 0011 hrs, the Eau Claire Fire Department responded to a sounding fire alarm at the University WI Eau Claire, Oakridge Hall. The incident was upgraded to a 1st alarm structure fire response due to confirmed reports of smoke in the building. When fire crews arrived they found smoke and heat conditions in the basement trash area. Crews worked quickly to search and extinguish the fire containing it to the trash chute. Ventilation efforts on each floor were coordinated to remove smoke and fire gasses. Crews metered the atmosphere before allowing students and staff to return. There were no reported injuries and the fire remains under investigation. Damage is estimated to be \$1000.
