



Communicable Disease Division

Provides essential services to prevent and control communicable disease outbreaks and prepares public health emergency response activities.

Protecting You Behind the Scenes

The communicable disease team works behind the scenes to keep you safe. It is committed to preventing exposures to diseases, monitoring outbreaks when they occur, and following up with people that are recieving treatment for a communicable disease. There are so many things that are looked at and all reports are taken seriously. This gives the team the ability to see disease trends early and prevent an outbreak from occuring. Therefore, you may not hear from the staff working in communicable disease but when you do, there may be some important information related to a disease that you should know about.

For example, Health Department staff in the communicable disease division monitor schools in Eau Claire County for patterns of certain diseases. In some cases, these staff work with schools, healthcare systems, and community members to report and monitor symptoms related to Norovirus in order to get ahead of the disease. This allowed the team to inform sick students to stay home, reducing the amount of people that were exposed to the disease. Overall, the public is better protected from exposure and makes it easier to prevent the spread of disease.

Improving Patient Care

The Family Planning Clinic (FPC) team implemented several positive changes improving the services and care we provide to the public. These include:

Electronic Medical Records System (EMR)

After months of planning and training, the new EMR was implemented and increases the function and resources of the clinic. The new EMR allows the clinic team to reduce storage costs, improve communication between nurses and clients, and provides opportunities to expand billing capacity.

Regionalization of Services

The FPC joined with four other Western Wisconsin Counties in 2019 to look at regionalizing some specialized service. Providing these services regionally will create opportunities to better meet the needs our populations, particularly in rural areas and smaller counties. We expect to a see a reduction in client time and cost as they will be able to access services on-site that were previously referred out to other providers.

Title X Recipient

The clinic also became a sub-recipient of a Title X grant. This federal funding prioritizes serving people and families with low-incomes. Many of the services offered in the FPC are supported by this funding allowing members of our community to meet reproductive health needs they may or may not otherwise be able to afford.

Community Health Promotion Division

Works closely with community partners to collaboratively identify and address those things that can improve our health where we live, work, and play.

Understanding Overdose Deaths

In 2019 Eau Claire and Dunn County collaborated to establish an Overdose Fatality Review Team in Eau Claire County. This team was created in response to increasing trends of substance abuse, misuse, and overdoses. A wide array of community partners such as public health, law enforcement, emergency medical services, medical examiners, health care providers, human services, drug treatment providers, behavioral health and schools are participating on the team. The goal of this team is to gain a better understanding of what is happening in our community around overdoses in order to prevent them from happening in the future. Connecting this data and information to better inform our prevention efforts as well as initiate policy or systems changes will be extremely beneficial in decreasing overdose deaths and drug related crimes in our communities.

Vaping Prevention & Education

2019 experienced another increase in electronic cigarette use and other vapor products. Although some people claim e-cigarettes are safe, these products are associated with negative health effects. These effects include addiction, brain damage, and lung disease. Health Department staff and community partners recognized the impact vaping has on youth. County residents were told about vaping's harmful effects and positive changes around access to these harmful products through retailer training, presentations to Student's Against Destructive Decisions groups, and retailer compliance checks.

Celebrating Fit Families

WIC participants involved in the Fit Families program celebrated together at a picnic at a local park in July. On this beautiful afternoon, 60 participants gathered, shared a healthy meal, played some fun games, and won prizes. UW-Stout dietetic students helped with the celebration by providing a fun food demonstration using fresh fruits and vegetables. Fit Families is a program offered to WIC families who have 3 or 4 year old children to improve physical activity, reduce screen time, increase fruits and veggies and decrease sweetened beverage intake. WIC dietitians have monthly contacts with their families for one year to coach them and provide tools to help them accomplish their goals.

Nurse-Family Partnership Program (NFP) Crock Pots

In response to requests made by NFP families to learn more about making healthy meals, we have implemented a Crock Pot Project. This Project teaches life skills around grocery shopping, food safety, meal planning, and basic cooking by providing a crock pot, a recipe book and ingredients for one healthy meal. The nurse guides her client through the making of the recipe during the home visit. The Crock Pot Project has increased our clients confidence around providing healthy meals for their families and has empowered them to use both the crock pot and recipe book for additional meals.

Environmental Sciences Division

Provides programs and services to enhance and protect environment quality. Our division increases awarenes of how environmental hazards conditions significantly influence the health and welfare of communities.

Rabies

The Eau Claire City-County Health department works with the Eau Claire Police Department and the Eau Claire Humane Association to maintain public safety during animal bites and exposures. To help prevent rabies exposure and disease, we run an active rabies program along with awareness efforts, clarification on individual situations with rabies exposure, and guidance during a known exposure. When a potential rabies exposure occurs, we verify the situation and follow-up to monitor symptoms, provide guidance, and enforce guarantines. In 2019, multiple animal bites or exposures were reported. These included 85 dog bites, 19 cat bites, and 57 other animal bites or exposures. 51 animals were tested. Of those animals tested, 4 bats tested positive for rabies. It is also crucial to keep cats and dogs current on their rabies vaccine to help protect them and yourself against rabies.

Transient Wells

The Eau Claire City-County Health Department works with the DNR to inspect and sample wells that serve water to the public, also known as transient noncommunity wells (TNC). There are 78 of these facilities in the county (churches, bars, restaurants, etc.) that are classified as 'TNC' based on the number of people served per day throughout the year. In 2019, seven of these facilities had positive coliform bacteria samples. Although coliform bacteria don't usually make people sick, if they are present in drinking water that can tell us that the water may have other harmful germs that can make people sick. This shows how important it is to sample public and private wells regularly for bacteria. If a facility has a positive sample, corrective action is performed to eliminate the bacteria and follow up samples are taken to ensure the water is safe. Four facilities had unsafe nitrate levels that pose a threat to the health of women who are or may become pregnant and infants under 6 months.

Regulation & Licensing Division

Inspects any facility that provides necessities such as food, water, and housing to the public. This division also inspects recreational facilities and temporary event spaces.

Inspection & Licensing

Ever felt ill after eating food or drinking beverages? You may think you got food poisoning from the last thing you ate, except it is most likely from what you consumed hours before then. The Eau Claire City-County Health Department's environmental health specialists inspect places that sell or serve food to the public. They take reports of foodborne illness seriously; however, they also want you to know that symptoms of illness caused by contaminated food begin 10-48 hours after the food is eaten. Want to know more about places you eat and buy food from? The Health Department also posts insepction reports of food-serving facilities located in Eau Claire County. These reports are available online at [Healthspace quicklink] where you have access to current inspections, violations, and corrections.

Housing

The Housing Program has been working with local partners to reduce potentially unsafe and unhealthy housing at the Maples Neighborhood in Eau Claire. We inspect mobile home parks and look at the exterior condition of mobile home park communities. The City of Eau Claire passed a public health-based housing code in 2017 which addresses external and internal housing conditions and is enforced by us. In the Maples Neighborhood, residents want to remain in their homes, but some were living in unsafe and unhealthy conditions. In collaboration with residents and local partners, units have been inspected for health and safety over time to minimize displacement of residents. Empty units are inspected before they are reoccupied and are prioritized based on external conditions. Complaints and emergency situations are investigated when needed. Within two years, the mobile home community went from having 48 occupied units to under 25 occupied units by the end of 2019.

Innovative Diabetes and Chronic Disease Program

ECCCHD is excited to work with a diverse group of community partners on chronic disease prevention to help meet people where they are and help make healthy choices easier for all. A big part of making the healthier choice easier is to talk about the systems in which we live, work, and play.

These systems include our workplaces, hospitals, schools, and many more. Each system has a set of rules or policies that impact our daily lives. Policies and systems are important and mostly made to be helpful for the safety of our community but can sometimes make healthy choices harder for individuals with different health needs.

By working together with these systems, we can make big community impacts through small system changes that better meet the needs of our community. ECCCHD is working to make system changes that address key health issues, such as prediabetes, diabetes, heart disease and other chronic conditions.

At a time when 1 in 3 people have prediabetes, which is a serious health condition that places people at a higher risk of developing type 2 diabetes, ECCCHD is bringing local community partners and systems together to increase access to and awareness of evidence-based programs, like the National Diabetes Prevention Program (National DPP). The National DPP supports participants in making lasting lifestyle changes that can reduce people's risk of developing type 2 diabetes by 58%.

To make this program successful and see long lasting changes, we'll need continued support from all our community partners. As our community changes, so do our health needs. As we move forward, we are committed to making new community partnerships that allow everyone's voice to be heard to meet these changing needs.

Together, with a growing group of local and state community partners, the ECCCHD is working to make system changes that have helpful, lasting, and powerful impacts on the health and wellbeing of our community. We look forward to the opportunity to partner with our community's many systems to make healthy choices easier for all.
