The Eau Claire Fire Department responded to a report of a fire in the residence at 2626 3rd Street. On fire crews arrival smoke could be seen coming from the roof and attic vents. The fire was quickly controlled by fire personnel. Fire damage was contained to the attic but the whole residence suffered smoke and water damage. Damage is estimated to be \$21,000. Two residents were assisted with shelter by the American Red Cross. There were no injuries and the fire remains under investigation.
