Mr. Johnathan reported that a tenant, who is the center of a potential lawsuit against the Housing Authority, had called the Health Department and tried to get them to say that the Housing Authority was somehow at fault. The Health Department could not do that because they did not find fault with

the Housing Authority. The tenant had also told the Health Department that she did not have an attorney, which is contrary to information the Housing Authority has.

The Housing Authority had previously issued a denial letter to the tenant and the tenant's attorney regarding this claim in October, though the attorneys and the tenant have six months to reply. Mr. Johnathan said that he did not think the board needed to take any action on this time on this matter.
