SATISFACTION AND TERMINATION OF A DEPARTMENT OF NATURAL RESOURCES INTERGOVERNMENTAL COOPERATION AGREEMENT

IN THE MATTER OF:

An Intergovernmental Cooperation Agreement, authorized by Wis. Stat. § 66.0301, between the City of Eau Claire and the Wisconsin Department of Natural Resources to mitigate, contain, and monitor the discharge of groundwater in and around the evaporation ponds (the Property) near the City of Eau Claire, Wisconsin well fields to protect public health and safety and minimize harmful effects of contamination from per- and polyfluoroalkyl substances (PFAS).

RECITALS SECTION

WHEREAS, on August 5, 2021, the City of Eau Claire (the City) and the Department of Natural Resources (the Department), together referred to as the Parties, entered into an Intergovernmental Cooperation Agreement (Agreement) to mitigate, contain, and monitor the discharge of contaminated groundwater in and around the evaporation ponds (the Property) near the City of Eau Claire, Wisconsin well fields to protect public health and safety and minimize harmful effects of contamination from per- and polyfluoroalkyl substances (PFAS); and

WHEREAS, the Agreement provides that "provisions of the Agreement shall be deemed satisfied when all 'agreements and obligations' identified [in the Agreement] for both the City and the Department have been satisfied or terminated by written consent of both Parties"; and

WHEREAS, each Party has satisfied its respective "agreements and obligations" identified in the Agreement; and

WHEREAS, the Parties desire to document the satisfaction and termination of the Agreement; and

WHEREAS, the Department has authority under Wis. Admin. Code ch. 728 and Wis. Stat. ch. 292 to enter into agreements with third parties and authority under Wis. Stat. § 66.0301 to enter into intergovernmental agreements with municipalities; and

THEREFORE, in consideration of, and in exchange for, the promises and mutual understandings contained in this Agreement, the City and Department agree to the following:

AGREEMENTS SECTION

Termination and Satisfaction

The Parties agree that the provisions of the Agreement have been satisfied and therefore, by the terms of the Agreement, the entire Agreement has terminated.
