Mr. Johnathan reported that in an effort to match the appropriately sized family with a suitable and appropriately sized Homeownership unit, it was necessary to adopt Occupancy Standards similar to those used by the other Housing Authority programs. Mr. Johnathan further discussed that if a situation arises that results in a family is eligible for unit that appears to be mismatched but is otherwise suitable, it would be brought to the Board for an exception to policy.
