Eau Claire Fire Department and the Eau Claire Police Department were dispatched to a report of a fire in a residence at 3626 Seymour Road lot 79. On the fire departments arrival, smoke and fire were coming from the windows of a mobile home. All occupants were out of the house on arrival but two pets were lost in the fire. There were no reports of injuries and the fire remains under investigation. The home is believed to be a complete loss and the American Red Cross is assisting the occupants. Damage is estimated at \$13,000.
