A GUIDE TO THE EAU CLAIRE TRANSIT APP



Eau Claire Transit app is the mobile ticketing application for public transit services in Eau Claire, enabling you to purchase and display tickets on your smartphone anytime, anywhere.



You can download the free app from the App Store or Google Play and purchase tickets to use on the day of travel, or store them in the secure mobile wallet for future use.

Here's how to use the Eau Claire Transit app to buy tickets and passes



Step 1

Download the Eau Claire Transit app from the App Store (for Apple iPhone users) or Google Play (for Android). Once the app has downloaded, open it up.



Step 2

Select 'Buy Tickets' to purchase a ticket or 'Ticket Wallet' if you have already bought a ticket and want to use it.



Step 3

Select the type of ticket or pass you require and accept the terms and conditions.



Step 4

Choose your preferred payment method. Credit or debit card information can be stored in the app to make the repurchase faster. Payments by Apple Pay are also possible.



Step 5

Once purchase is complete, tickets and passes can be found in the 'Ticket Wallet'.



Step 6

Scan the activated ticket on the ticket validation machines aboard our buses. When the light turns green on the validator, you're ready to go!

UNDERSTANDING THE JUSTRIDE FARE VALIDATOR

- Visual and audible responses are made to each scan
- Tactile guides to assist visually impaired riders
- Mobile app barcodes are scanned against the white optical reader
 - Cards are held against the black 'contactless' pad

HERE ARE THE TYPES OF VALIDATOR RESPONSES YOU COULD GET AND WHAT THEY MEAN:
