1. Update of Bicycle and Pedestrian Plan. The current Bicycle and Pedestrian Plan was adopted in 2010. The Commission initiated the process of updating the plan in 2015. The focus of the update is to review the bicycle routes shown in the plan and the areas identified as needing further study. A preliminary draft of the revised routes has been completed and the Committee continues to discuss possible changes. At the request of staff, BPAC will also provide suggestions of other potential bicycle boulevards such as for Grand Avenue. Plan Commission review of the update in 2017 is anticipated. 2. Update of Metropolitan Bicycle and Pedestrian Plan. West Central Regional Planning Commission initiated a process in 2016 to update the Metropolitan Bicycle and Pedestrian Plan. Representatives from BPAC, as well as Engineering and Planning staff have attended periodic committee meetings to assist in providing input to WCRPC. It is anticipated that the plan will be completed in 2017. As an outgrowth of the plan, a committee including two members of BPAC and staff have met with representatives of area jurisdictions to discuss the feasibility of a regional signed bicycle route system within the Eau Claire-Chippewa urban area.
