AGENDA ITEM #1: Call to Order

Chair Brian Graff called the meeting to order at 3:30 p.m.

AGENDA ITEM #2: Roll Call

Brian Graff took the roll and a quorum.

AGENDA ITEM #3: Approval of July and August 2023 Meeting Minutes

Committee member Steve Betchkal made a motion to approve of the minutes. Seconded by Committee Member Amy Kalmon. Unanimously approved.

AGENDA ITEM #4: Open Public Comment Period for Items that do not appear on this Agenda.

Guest Eleanor Wolf of the Citizen Tree Committee spoke out about the importance of trees and hope that the zoning code update will include a tree preservation ordinance. Wolf shared hopes that the committee would stand as advocates for tree preservation

Eleanor shared her concern of off-leash cats within the city the bird population

Kathy Campbell shared her concern of single use plastic, organic material, and other items that end up in the landfill. She hopes that the goal of recycling is expanded on the work plan. She stated hope that more recycling education will be promoted.

Sue Waits, JONAH, asks that the community acknowledges that single-use plastic is an issue.

AGENDA ITEM: Item #5A Virtual Attendance Policy

Ms. Berg shared that a second reading of the virtual attendance policy is required for an amendment to the bylaws. Committee members spoke in support of the policy amendment. Committee member Amy Kalmon moved to approve the policy. Committee member Pesicka seconded. The motion carried unanimously.

AGENDA ITEM: Item #5B Update on the Energy Efficiency Navigator Program

Ms. Berg shared an updated that staff hopes to leverage EECBG funding within the voucher program and CIP funding to assist landlords in making their rentals more energy efficient.

AGENDA ITEM: Item #5C Recommendation on Xcel Energy's Renewable Energy Rider Program

Mr. Noel shared about the shared solar program. The City is partnering with Xcel to both reach their renewable energy goals. The PSC has approved of the program, but not this specific project. Committee members spoke in support of the solar project and asked clarifying questions. The City would lock in a set rate for years to come. Committee member Pesicka made a motion to support the project and to communicate the support to city council. Committee member Halmstad seconded. Carried unanimously.

AGENDA ITEM: Item #5D Review of Work Plan

Staff went through the work plan line by line and asked for feedback on proposed carryover work from 2023 to 2024. The committee members were agreeable to the work that will continue being on-going. Committee member Betchkal requested a change in the layout of the workplan.

Libby Stupak spoke in favor of tree preservation and protection and enforceable ordinances. Tree boulevard reimbursement fee to be revised to include trees near the sidewalk if they don't have a sidewalk. Education about lighting ordinance and more enforcement. She also spoke in favor of the bird friendly design guidelines.
